All notary bonds are in force upon issue and will not be canceled or refunded. A.N.S. will correct and reissue notary bonds at our own expense in the case of errors caused by us. Notary errors & omissions insurance may be canceled upon request of the policy holder.

Refunds of premium will be issued from and at the discretion of Western Surety Company an underwriting company of C.N.A. Surety.

The first year premium of Probate & Court bonds is fully earned and will not be refunded.

To cancel further renewals of these bonds proper paperwork must be submitted to our office or Western Surety Company an underwriting company of C.N.A. Surety directly.

Notary training seminars
